Court Network Safety Net Program



Court Network's Family Court Program- Safety Net, has launched in Queensland and currently have an in-court team at Brisbane Family Court and a Telephone Service supporting court users across the state.

This volunteer service provides an enhanced model of support by actively collaborating with court users and in-court services, including but not limited to FASS and duty lawyer services, to support court users to bridge service gaps. All services are provided by highly trained and skilled volunteers and is available to all court users, including, victims, witnesses, accused, family, friends, parents, and guardians.

The Safety Net Program provides non-legal support, information, referrals, and advocacy. The service is a free confidential community service which can provide a range of support services, some of which are included below:

- Non-legal information about what happens before, during and after court
- Information about court etiquette, explaining court processes and how to navigate court on the day
- Assist you to get the help you need to address your safety concerns and help to arrange access to safe spaces at court
- Referrals to legal services and community legal centres.
- Help you to understand potential outcomes and next steps that you might have to take
- Providing referral pathways to key support services like FASS, lighthouse Model, family services, family violence
- Providing emotional support, before, during and after your day at court
- Information on how to navigate online court and web-ex hearings



Safety Net Program

Our highly trained Networkers provide non-legal support, information, referrals, and advocacy to court users, friends, and family members accessing or engaging with the Family Court.

Support is available pre-court, during court, and post-court.

Call our Telephone Service to speak to one of our friendly Networkers. They will help you navigate the system, explain court ettiquite and processes, and provide referral pathways.

Evaluation of the Children's Contact Service Activity

This report sets out the findings of the Evaluation of Children's Contact Centre Activity.
Children's Contact Services (CCSs) facilitate the supervision of parenting time and changeover for families, most commonly where the parents are separating, or have separated, and require a safe and neutral venue to enable contact to take place. This study evaluates the work and activity of these services.

Review of Family Relationship Services

The AIFS has been commissioned to conduct research in relation to the AGD Funded Family Relationship Services Program. This review will included 11 components including stakeholder consultations and interviews, data analyses, surveys of Family Law professionals and interviews with separated adults who have used these services.

The review is due for completion on 28 June 2024.



What makes a family?

This <u>research report</u> produced by AIFS outlines findings from the Families in Australia Survey.

One of the findings was:

Aboriginal and/or Torres Strait Islander people were much more likely to rate legal ties or obligations as important or very important compared to non-Indigenous Australians (48% vs 30%).
