The Network seeks to help professionals build strong, collaborative relationships, strengthen referral pathways and stay informed through events, training & resources.

The Network is staffed by a 0.3 FTE Project Officer (currently Shontelle Petrie) and guided by a steering committee, made up of professionals from independent organisations who work with separating or co-parenting families.

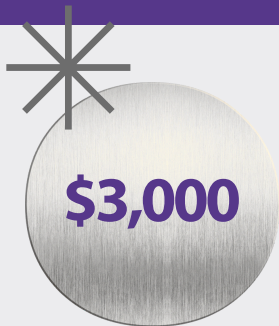
