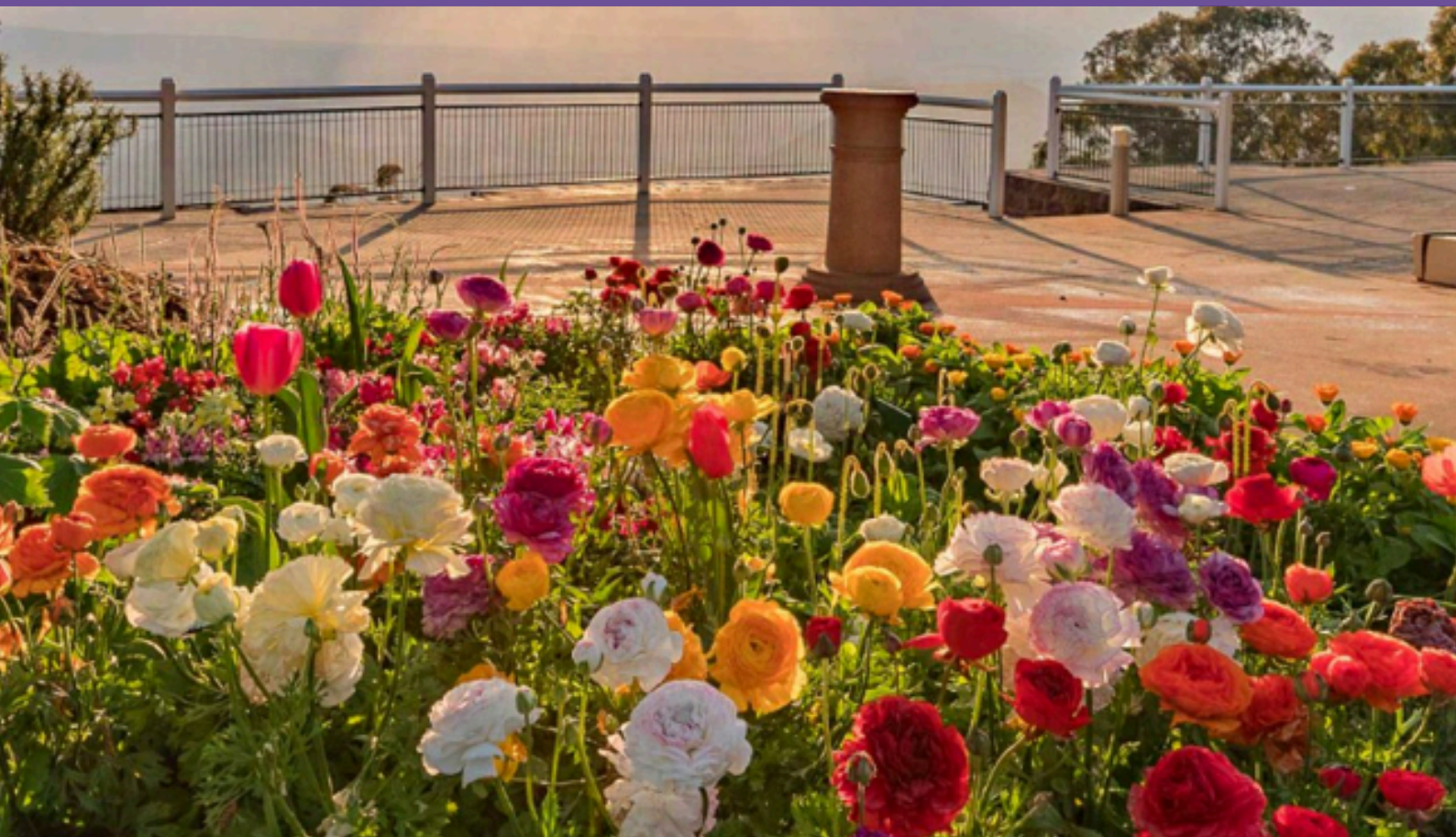

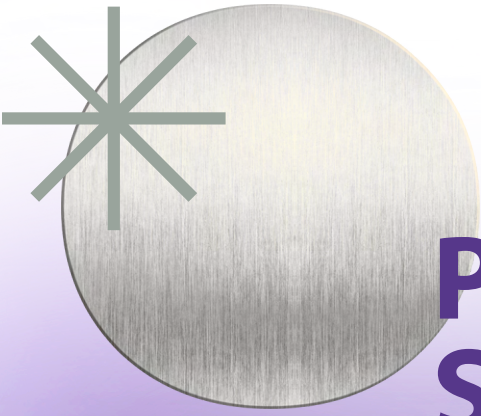

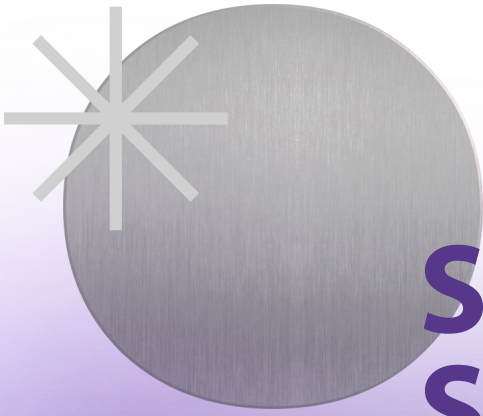

Terms and Conditions

LEGAL ENTITY FOR TSWQ FLPN

Toowoomba and South West QLD Family Law Pathways Network (TSWQ FLPN) is funded by the Department of Attorney-General and auspiced by CatholicCare Social Services. The legal entity that operates CatholicCare Social Services is The Corporation of The Roman Catholic Diocese of Toowoomba: CatholicCare Social Services Services.

GST

Where appropriate, Goods & Services Tax (GST) is applicable to all goods and services offered by TSWQ FLPN and all prices in this document are inclusive of GST. GST is calculated at the date of publication of this document. TSWQ FLPN reserves the right to vary the quoted prices in accordance with any movements in the legislated rate of the GST.

BOOTHS

TSWQ FLPN reserves the right to allocate booths for Sponsors and rearrange the floor plan without notice.

Any Sponsor who wishes to have a booth must have Public and Product Liability insurance to a minimum of \$10 million. A copy of the Sponsor's public and product liability insurance certificate must be submitted with the Booking Form.

NO SPEAKING ROLES FOR SPONSORS

No Sponsor will be given the opportunity to speak at the conference.

AUDIENCE AND RESULTS

TSWQ FLPN makes no guarantees on attendee numbers, lead generation, media coverage, or sales outcomes.

CONFIRMATION OF SPONSORSHIP

Once TSWQ FLPN receives the booking form from an organisation, TSWQ FLPN will consider whether to accept the offer of Sponsorship.

TSWQ FLPN reserves the right to refuse Sponsorship from any organisation.

A letter of confirmation will be provided to confirm that the offer of Sponsorship has been accepted, together with the tax invoice. The invoice is payable 14 days from the date of the tax invoice.

LOGOS

The Sponsor must provide logos (vector .ai/.eps/.svg and high-res .png), brand guidelines, and any advertising copy to TSWQ FLPN at the time of payment of the tax invoice. Late delivery may reduce or limit benefits without refund.

COMMENCEMENT OF SPONSORSHIP

The Sponsor has no rights to any of the benefits of their Sponsorship Package until TSWQ FLPN receives payment for the specific Sponsorship Package.

PUBLICITY ON CONFIRMATION

A LinkedIn Post will be published announcing each new Sponsor once TSWQ FLPN receives payment and the Sponsor's logo.

EXCLUSIVITY

There is only one Platinum Sponsorship Package and two Gold Sponsorship Packages. The Silver Package is non-exclusive.

Terms and Conditions continued

ATTENDEE DATA

TSWQ FLPN will not provide any personal information of attendees to the Sponsor.

If the Sponsor obtains personal information from attendees, the Sponsor will only use that data in accordance with Australian Law including Privacy Act 1988 (Cth) and applicable Australian Privacy Principles.

INTELLECTUAL PROPERTY

The Intellectual Property of organisations will remain their own.

TSWQ FLPN will be responsible for creating marketing material for the conference that can be shared by the Sponsor.

The Sponsor permits TSWQ FLPN to use the Sponsor's Intellectual Property for the purposes of complying with the Sponsorship Agreement.

TSWQ FLPN will provide the Sponsor an opportunity to review any material with its logo before it is published. The Sponsor must review the material without delay and not unreasonably withhold approval.

RECORDINGS & PHOTOGRAPHY

TSWQ FLPN may photograph, record, and livestream Event content. The Sponsor acknowledges its logo may appear incidentally in such materials. TSWQ FLPN owns all Event recordings and photography.

The Sponsor may not record and photograph any of the Event content.

INDEMNITY

The Sponsor indemnifies TSWQ FLPN and its personnel against third-party claims arising from Sponsor's materials, products, or conduct at the Event, except to the extent caused by TSWQ FLPN.

MORAL AND BRAND SAFETY

TSWQ FLPN may remove or refuse materials that are inaccurate, unlawful, misleading, political, discriminatory, or inconsistent with TSWQ FLPN's values or program purpose.

DISCOUNT AND REFUND

TSWQ FLPN will not discount or refund for any facilities not used or required as part of the Sponsorship Agreement.

TSWQ FLPN will not refund any Sponsorship Monies once they have been received unless TSWQ FLPN cancels the conference.

CANCELLATION

If the event is postponed, TSWQ FLPN will not refund Sponsorship Monies.

If the event is cancelled by TSWQ FLPN, TSWQ FLPN will refund 85% of the Sponsorship Monies.

GOODIE BAGS

Up to two (2) items (e.g., branded merchandise) per Sponsor, subject to TSWQ FLPN pre-approval for content, safety, and suitability. Items must be delivered no later than 21 days prior to the conference.

Sponsorship Packages Definitions

PREMIUM LOGO PLACEMENT

The Sponsor's logo will be displayed in a high-visibility position ahead of lower-tier Sponsors. This includes larger sizing, priority positioning, and placement on primary event communications, as determined by TSWQ FLPN.

PROMINENT DISPLAY OF COMPANY LOGO

The Sponsor's logo will be placed in a clearly visible and noticeable position within TSWQ FLPN's promotional or event materials. This includes positioning the logo at a size, location, and frequency appropriate to the Sponsor's package tier, ensuring it stands out relative to lower-tier Sponsors while remaining consistent with the overall design and layout of the material.

PROMOTIONAL MATERIALS

Any marketing or communication content produced by TSWQ FLPN to promote the Event. This includes (but is not limited to) the Event program, flyers, brochures, digital banners, social media posts, website content, registration pages, and email marketing.

EVENT SIGNAGE

Any physical or digital signs displayed during the Event made specifically for the Event. This may include pull-up banners, printed signs, directional signage, holding slides, screen graphics, or welcome boards used at the venue or within the Event's online platform.

STAGE BACKDROPS

Printed or digital background displays used behind speakers during the Event. This includes physical stage banners, media walls, projector screens, or digital presentation backdrops used.

PRESS RELEASES, NEWSLETTERS AND MARKETING CAMPAIGNS

All media and communications distributed to the public or to TSWQ FLPN's professional network to promote the Event. This includes written press statements, email newsletters, LinkedIn and other social media campaigns, and any communication materials designed to raise awareness or promote attendance.

DEDICATED SOCIAL MEDIA CAMPAIGNS

Promotional posts or digital content created specifically to acknowledge or promote the Sponsor on TSWQ FLPN's official social media channels.

There will be two posts per Sponsorship Package. The first, the introduction of the Sponsor. The second, a post about the Sponsor. These posts are separate from general event announcements and are created specifically for Sponsor recognition.
